PREAMBLE:-

The Hon'ble Chief Minister in his Budget Speech for the year 2014-15 read at S.No. (1) above has declared to increase the food tariff to the students of Post-Matric Hostels and Murarji Desai Residential Schools of Minority Welfare Department from Rs. 1,000/- to Rs 1,100/- and for Pre-Matric Hostels from Rs. 900/- to Rs. 1,000/-.

In the Government order read at S.No. (2) above the food tariff has been increased to the students of Pre-Matric Hostels and Post-Matric Hostels and Murarji Desai Residential Schools of Minority Welfare Department.

In the proposals read at S.No. (3) Director, Directorate of Minorities has proposed that due to the escalation of prices of essential commodities, gas and the commodities required for day to day use, it is extremely difficult to provide quality food to the students of Pre-Matric hostels and Post-metric hostels and Murarji Desai Residential Schools of Minority Welfare Department and has requested to increase the food tariff as detailed below:

Director of Directorate of Minorities has further proposed to provide the additional allocation of Rs. 317.05 lakhs under District Sectors Schemes Head of Account for the year 2014-15. Rs. 53.80 lakhs to the Pre-Matric Hostels, Rs. 37.50 lakhs to the Post-Matric Hostels, Rs. 138.30 lakhs to the Morarji Desai Residential Schools, Rs. 23.21 lakhs to the Aided hostels of minorities and Rs. 64.24 lakhs to the Orphans and Destitute Students of Orphanages of Minorities NGO's.

The proposals has been examined in detail and hence the following order:-
